If an error is made the dog may be disqualified by the Committee of the Kennel Club. <b>ENTRIES FOR FIELD TRIALS WILL ONLY BE ACCEPTED FROM GUNDOGS REGISTERED AT THE KENNEL CLUB IN THE GUNDOG GROUP</b> (vide Reg. J1.a., J7.a. &amp; B20) and if a registered dog has changed ownership the <b>TRANSFER</b> must be applied for before the closing of entries. When entering more than one breed or variety, use if possible, a separate form for each.
